is hereby licensed as a Pest Controller in accordance with the Controlled Substances (Pesticides) Regulations 2017 and is authorised to use:

**FUNGICIDES; HERBICIDES; INSECTICIDES (EXCLUDING ARSENIC TRIOXIDE);
RODENTICIDES**

for the following pest control work:

DOMESTIC AND COMMERCIAL PEST CONTROL (INCLUDING TIMBER PESTS)

Subject to the conditions imposed by the Controlled Substances (Pesticides) Regulations 2017 and the following conditions:

1. The holder of this licence will maintain any premises and equipment used for the purposes of the holder's pest control business in a clean, efficient and safe working condition.
2. The holder of this licence will ensure that any pesticide, while handled or used in the course of the holder's pest control business, is under the direct control of the holder of a pest management technician's licence.
3. The holder of this licence will ensure that any unused pesticide or any container used to hold a pesticide in the course of the pest controller's business is disposed of in a manner not likely to endanger the health of any person.
4. The holder of this licence must ensure that the holder of a Limited Pest Management Technicians licence is supervised in accordance with Regulation 4 of the Controlled Substances (Pesticides) Regulations 2017.
5. The holder of this licence, where authorised to conduct vertebrate pest control, must ensure that:
 - (a) 1080 baits used for vertebrate pest control are obtained only from the Regional Landscape Board responsible for the area being baited or treated, or from the Department for Environment and Water for use in Biodiversity Conservation Programs; and that

- (b) Felixer 1080 Cartridges are obtained from an authorised supplier on referral from the Regional Landscape Board responsible for the area being treated, or from the Department for Environment and Water for use in Biodiversity Conservation Programs.
6. Such other conditions as the Licensing Authority thinks fit to impose and specifies in the licence or by notice in writing given personally or by post to the holder of this licence.
7. Unless individually endorsed, in accordance with Regulation 25(6) of the Controlled Substances (Poisons) Regulations 2011, an endorsement for 'Fumigants' excludes cyanogen and chloropicrin and excludes methyl bromide unless its use is for quarantine pre-shipment (QPS) purposes or for non-QPS purposes that have been approved under critical use exemptions as determined by the Commonwealth Department of Agriculture, Water and the Environment.
8. Unless individually endorsed, in accordance with Regulation 25(6) of the Controlled Substances (Poisons) Regulations 2011, an endorsement for 'Rodenticides' excludes strychnine unless in possession of less than 5 kilograms of baits designed for destroying mice and does not exceed 0.5% of strychnine.
