RESTRAINT

Do NOT place in areas that are routinely washed.

Domestic, Commercial and Public Service Buildings	German and other Common cockroaches.	Apply 1-3 spots per m ² . Recommended spot size is 0.25 - 0.5 g. Increase the number of spots (up to 3) and spot size depending upon severity of infestation and species present.	Gel placement should be at or near areas where cockroaches gather, such as in cracks and crevices.

GENERAL INSTRUCTIONS

To apply the gel, remove the cap on the nozzle and touch the tip to the surface to be treated and depress plunger slightly. Recap the dispenser after treatment is completed and return cartridge to the outer pack. Re-apply according to remaining level of infestation, when bait is no longer visibly present. A visual inspection of gel placements is recommended one month after initial treatment.
